# Lesson Plans Overview For Family Child Care Homes

### WHO?

Four and Five Star family child care homes must implement current weekly lesson plans.

Lesson plans must be:

- developmentally appropriate
- align with Oklahoma Early Learning Guidelines (ELGs) or Oklahoma Academic Standards and these are documented on the lesson plans
- provide for children's various ages, abilities, developmental stages, social-emotional development, special needs, and interests
- include at last two daily caregiver-led developmentally-appropriate physical activities
- shared with families
- include at least 15 minutes of daily reading to children

## WHY?

Carefully planned lesson plans provide rich learning environments for young children which are tied to school readiness and lifelong excitement for learning. When we see children as capable, we partner with them to develop environments that meet their interests and needs.

### WHAT?

- High quality lesson plans are based on children's wonder, curiosity, interests, and needs.
- Infant and toddler lesson plans focus on developing secure relationships with caregivers and family
  members. Although social, emotional, and language development take center stage, these interactions
  and experiences also lay the foundation for vocabulary and concepts that support later academic
  development across all subject areas.
- Preschool and school age lesson plans build upon earlier stages, deepen, and extend to reflect
  children's more complex knowledge and skills across all subject areas. Continuing to provide culturally
  and linguistically sustaining care and supporting all domains of development as well as all subject areas
  remain essential.
